TERMS AND CONDITIONS

All participants in the 4 Aussie Heroes Foundation Limited’s 2020 “Pedals ‘n Medals” Bike Ride (Road) Event and related activities, to be held 16-17 October 2020, (“the Event”), are required to read and sign the following conditions of entry to acknowledge their understanding of the conditions and their responsibilities, and to accept same.

PARTICIPANTS DECLARATION

1. I acknowledge that the Event will be held on public roads in Sunshine Coast & Hinterland of Queensland using _____ (tba) _____ as the base. I agree to abide by the rules, requirements and obligations governing the Event and the road rules of Queensland. I acknowledge that cycling is a potentially dangerous activity and I am aware of the risks when riding on public roads open to traffic. I am also aware of the risks associated with colliding with other bicycles or pedestrians and agree to exercise proper care and skill to avoid any collision. I am also aware of the risks of crashing due to uneven surfaces, potholes or gravel.
2. The decision to participate in the Event is my own and I accept all risks associated with participation in the Event, including but not limited to loss of life or permanent injury. I, in consideration of and as a condition of acceptance of my entry in the Event for myself, my heirs, executors and administrators, hereby waive all and any claim, right or cause of action which I or they might otherwise have for or arising out of my loss of life, damage or loss of any description whatsoever which I may suffer or sustain in the course of or consequent upon my entry or participation in the Event.
3. In consideration of 4 Aussie Heroes Foundation Limited permitting me to enter and participate in the Event, I release its servants, agents, sponsors, hosts, medical paramedical personnel, policy officers, and any other personnel engaged in promoting or staging the Event from all claims for injury, loss, or damage of whatever kind I might suffer as a result of any acts or omissions, whether through negligence or otherwise, of 4 Aussie Heroes Foundation Limited, its servants, agents, sponsors, hosts, medical paramedical personnel, policy officers, and any other personnel engaged in promoting or staging the Event, in relation to the Event, and I will indemnify 4 Aussie Heroes Foundation Limited, its servants, agents, sponsors, hosts, medical paramedical personnel, policy officers, and any other personnel engaged in promoting or staging the Event, for any liability, loss, costs, damages or expenses to it or them associated in any way with any act or omission whether negligent or otherwise on my part.
4. I acknowledge that I have sole responsibility for my personal possessions and equipment during the event.

5. I attest that I am physically fit and have peloton riding experience and can maintain the agreed baseline fitness speed of 24 kms per hour during the duration of the event and have sufficiently trained and/or will train for this Event. If requested, I agree to provide with my entry form, if required, a signed doctor's certificate attesting to my physical fitness to participate in the said Event.
6. I consent to receive medical treatment which may be deemed advisable in the event of injury, accident and/or illness during the Event.
7. I agree to allow my bike to be inspected and will abide by the decision of 4 Aussie Heroes Foundation Limited as to the ride worthiness or suitability for the Event. Notwithstanding such an inspection, I acknowledge that at all times, I remain responsible for ensuring that my bike is ride worthy, has been properly maintained and serviced and is in a suitable condition to be able to undertake the Event safely. I equally agree to no tri bars or tri bikes and no use of MP3 players or the like, whilst riding.
8. I acknowledge that all riders must wear helmets and I accept that I must have a road bike (no mountain bikes, hybrids or tandems) and that prior to the event the bike will have, at a minimum, had a safety check by a reputable mechanic or by someone who is sufficiently skilled and experienced. I accept that all riders must adhere to the Event rules, requirements and obligations as advised or face the possibility of being disqualified/removed from the Event.
9. I acknowledge that there is an expectation that each rider will work towards a fundraising target of \$1,000, being significantly less due to the current situation. (Such donations to 4 Aussie Heroes Foundation Limited are tax deductible.)
10. I acknowledge that 4 Aussie Heroes Foundation Limited will, with the Event Management contractor, review the weather conditions prior to and during the Event and may need to adjust, reduce, move the date for or cancel this Event for safety reasons if the weather proved to be a risk to health and the completion of the ride. I agree to abide with whatever decision is made by 4 Aussie Heroes Foundation Limited should unforeseen weather conditions place the Event and peoples' health at risk.
11. Registration fees, sponsorships and funds raised are non-transferable and non-refundable unless agreed to in writing by 4 Aussie Heroes Foundation Limited 10 days prior to the Event, and only on written request to 4 Aussie Heroes Foundation Limited.
12. In view of the changing circumstances relevant to COVID19, in the event that the 2020 Ride cannot go ahead on 16-17 October 2020, it would be postponed to a later date with no further fee to be paid by Riders or Sponsor who had paid for 16-17 October 2020.
13. I consent to the use of my name, race results, image, voice, statement or otherwise, and applicable age bracket, to promote or report on the Event in any form of the media and without payment or compensation.
14. This is a semi supported ride and participants will receive assistance throughout the ride. Assistance will be provided free of charge but bicycle products will be supplied on a "user pay" basis.
